Keynote Speakers



David Ernst, Ph.D., is the director of the Center for Open Education at the University of Minnesota. Dr. Ernst is the founder and executive director of the Open Textbook Network - a higher education community representing over 850 colleges and universities working to advance open education locally and globally. He also created and manages the Open Textbook Library, the most comprehensive catalog of

open textbooks, complete with faculty reviews.



Nicole Allen is the director of Open Education for SPARC, an international alliance of academic and research libraries working to make Open the default in research and education. Nicole is an internationally recognized advocate and thought leader in the Open Education movement, who has worked tirelessly to expand access and affordability of education in the digital age since her own days as a college student. Over

the last decade, Nicole has given hundreds of talks and trainings in more than a dozen countries on Open Education, education policy, and grassroots organizing. Based in Washington, D.C., Nicole's portfolio at SPARC includes a robust state and federal

policy program, a broad librarian community of practice, and a leadership program for OER librarians. Learn more at www. sparcopen.org.



Susan Heegaard is the president of the Midwestern Higher Education Compact. Heegaard represented Minnesota, serving on MHEC's Commission as a commissioner alternate from 2004-2009, during her time as commissioner of the Minnesota Office of Higher Education. From 2013-2018, she worked as a senior consultant with HCM Strategists, a public policy firm, primarily with the Lumina Foundation Strategy Labs, connecting state

and system leaders with effective approaches aimed at improved postsecondary education approaches and outcomes. She was also a vice president and education team leader for the St. Paul based Bush Foundation.

Heegaard has guided policy under two governors and a U.S. senator, worked for the Minnesota Chamber of Commerce, the Minnesota Private College Council, and the Minnesota Planning Agency. Heegaard holds a law degree from Mitchell Hamline College of Law and a bachelor's in economics and government. She began working for the Compact in November 2018.
